Title: City Council Resolution No. 2022-58
A Resolution of the City Council of the City of Needles, California Confirming and Adopting an Itemized Statement of Cost for Abatement of Property located at 2234 Casa Real Street, also known as APN 0185-351-45-0000

Background: On September 16, 2021, an abatement hearing was held declaring the dilapidated home and its contents and all miscellaneous debris on the property a public nuisance. The Administrative Hearing Officer further ordered staff to obtain an abatement warrant from the court, collect all fines, demolish the structures and remove all debris from the property.

On March 25, 2022 an Abatement Warrant was issued (Case No. SBSW 22-01389) for the city to take the appropriate actions to remove and abate the aforementioned public nuisances on the property. The Court ruled in favor of the City awarding any fees and costs expended to date plus all costs of abatement to be placed as a lien on the property totaling \$16,400.94.

On or about April 19, 2022, the Property was returned to acceptable standards as established in the City's Municipal Code.

Fiscal Impact: The potential City reimbursement in the amount of \$16,400.94

Environmental Impact: N/A

Recommended Action: Approve City Council Resolution 2022-58, Confirming and adopting an itemized statement of cost for abatement of property located at 2234 Casa Real Street, also known as APN 0185-351-45-0000, file said resolution with the County Recorder placing a lien on the property.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEEDLES
CALIFORNIA, CONFIRMING AND ADOPTING AN ITEMIZED
STATEMENT OF COST FOR ABATEMENT OF PROPERTY
LOCATED AT 2234 CASA REAL STREET, NEEDLES, CA 92363,
ALSO KNOWN AS APN 0185-351-45-0000**

WHEREAS, pursuant of Section 116 of the 2012 International Building Codes, property Located at 2234 Casa Real Street (Assessor's Parcel No. 0185-351-45-0000) was declared to be a safety hazard/public nuisance and was ordered abated by Mark Marnati, serving as Hearing Officer; and

WHEREAS, proper notification to the property owner, Robert Boda and Michele Boda, to abate the nuisance was given on September 16, 2021; and

WHEREAS, the property owner did not, in fact, clean the premises as ordered; and thereby the City of Needles commenced to do the work with a total cost of sixteen thousand four hundred dollars and ninety-four cents (\$16,400.94) being charged to the property owner payable by said owner of the property, or by the beneficiary of any trust deed or by any other interest party; and

WHEREAS, On March 25, 2022 Case No. **SBSW 22-01389** was filed with the Superior Court of the State of California County of San Bernardino and an itemized statement of costs for work performed by the City is hereby attached to this Resolution for further particulars was submitted.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Needles California, hereby confirms and adopts the itemized statement in the amount of sixteen thousand four hundred dollars and ninety-four cents (\$16,400.94) for the work performed by the City of Needles. The City Council further resolves that the statement shall be paid by the owner of the premises, beneficiary of any trust deed concerning the premises, or any other party interested in the property; and

BE IT FURTHER RESOLVED, that if the said statement is not paid, said changes shall constitute a lien on the real property upon which the public nuisance was abated and shall be collected as a special assessment against the real property; and

BE IT FURTHER RESOLVED, that the property in this Resolution is located in the City of Needles, State of California, and more particularly described as Assessor's Parcel No. 0185-351-45-0000, record of San Bernardino County; and

BE IT FURTHER RESOLVED, that the Assistant City Manager is hereby directed to file with the Assessor and Tax Collector of San Bernardino County, certified copies of this Resolution, and further the Director of Development Services shall record said Resolution with the San Bernardino County Recorder; and

BE IT FURTHER RESOLVED, that the Assistant City Manager should direct the San Bernardino County Assessor to enter the amount of the charge against the real property described in this Resolution on the current assessment rolls; and

BE IT FURTHER RESOLVED, that the San Bernardino County Tax Collector shall add the amount of the assessment to the next regular tax bill against the property for municipal purposes.

23 The Court, having read and considered the Application (“Application”) of the City of
24 Needles, California (“City”), for this Warrant to Abate Public Nuisances (“Abatement
25 Warrant”), the Memorandum of Points and Authorities in support thereof, the Declaration of Adrian
26 Chavez (“Chavez Declaration”), and the Declaration of 24 Hours Notice, and the Court being
27 familiar with the conditions of the property described in the Declaration and the Application, and
28 finding good cause exists, does hereby order as follows:

1 1. City Manager or his designee may, after 24 hours following posting of this
2 Abatement Warrant in a conspicuous location on the Property, enter onto the real property having
3 APN 0185-351-45-0000, located at 2234 Casa Real Street, Needles, California ("Property"), and
4 may abate the public nuisance by: (1) cleaning and correcting violations in all structures on the
5 Property described in the Chavez Declaration, and (2) removing and disposing of all miscellaneous
6 debris and vegetation on the Property and all contents inclusive including but not limited to
7 correcting the following vilations of Needles Municipal Code:

8 Section 14-32 of the Code:

- 9 (g) Overgrown, dead, decayed, or hazardous trees, weeds and other vegetation
- 10 (h) Building exterior which are maintained in such condition to become
- 11 defective, unsightly, or no longer viable
- 12 (i) Unlawful storage of material on property
- 13 (k) Abandoned, broken or neglected equipment
- 14 (m) Materials visible from public street
- 15 (p) Unsightly appearance
- 16 (t) The substantial lack of maintenance of grounds within the City on which
- 17 structures exist, where the grounds are visible by the public from a right of
- 18 way or neighboring properties. Such condition would have a tendency to
- 19 depreciate aesthetic and property values or surrounding properties
- 20 (u) Property maintained, in relation to others, establish prevalence of depreciated
- 21 values, impaired investment
- 22 (v) Maintenance of premises in such condition as to be detrimental to the public
- 23 health, safety, or general welfare, or in such manner as to constitute a public
- 24 nuisance as defined in the Civil Code 3480
- 25 (z) Other nuisances as declared by any state, county or city statute, code or
- 26 regulation to be a public nuisance, correcting the following violations of the

27 International Property Maintenance Code:

- 28 301.3 Vacant structure no maintained

2. The City Manager or his designee may use City forces, private contractors and/or such other reasonable methods as may be appropriate to remove and abate the aforementioned public nuisances on the Property. Reasonable force only shall be used. The work shall be accomplished between 8:00 a.m. and 6:00 p.m. only.


3. Abatement pursuant to this Abatement Warrant shall be carried out no later than ninety (90) days from the date this Abatement Warrant is issued.

4. This Abatement Warrant shall be posted on the Property at least twenty-four (24) hours before the abatement begins.

5. A return describing all the actions taken pursuant to this Abatement Warrant shall be returned to this Court no later than fourteen (14) days after execution of the Abatement Warrant.

6. City is awarded fees and costs expended to date plus all costs of abatement to be performed. City shall submit a bill with the return on Abatement Warrant. The City Council may authorize a lien to be placed upon the Property at the conclusion of the abatement proceeding and such amount may be collected through the tax rolls or any other collection measure deemed appropriate by the City.
